Goa-2000.zip bb fileuWith the (inevitable) failure of health care reform in the U.S. House of Representatives, the American people have two choices: 1) go back to a flawed system that contributes to social injustice and contributes to economic instability in the long run, or 2) to take charge of our health care ourselves, a struggle which is being waged in a way reminiscent of the period just prior to the American Revolution. The first scenario is the one the United States Congress has chosen. The second is the route that a growing number of Americans will follow. The struggle over health care reform is as American as the New England town meeting, and it is being led by the American people who have been awakened by the many wrongs of the current system. What is happening in Massachusetts is one of the many front lines of this struggle, which will soon include every state in the Union. As of May 2010, the new Massachusetts Health Connector, a central agency that will receive state subsidies to assist people with health insurance, had been established. In this state, decisions about health coverage are to be made by bureaucrats who have been freed from all accountability. The new law places a small group of state bureaucrats who will, for the first time, decide if a child has health insurance by being able to decide who has insurance and who does not, and through what method. The state bureaucracy can decide who can get insurance and how much to spend on insurance. The state bureaucracy can decide if a person's health care will be paid for by the state or paid for by the person themselves, or if anyone will pay for it.
