Typically, such tools include a housing containing a motor that drives a fastener into a workpiece. The housing further includes a mechanism for opening and closing the fastener (e.g., a pivoting trigger, which is actuated by a user's finger) and an output mechanism for projecting the fastener through the workpiece. These tools are designed to be used either by hand or in combination with a pistol grip. Typically, these tools include a trigger that protrudes from the housing and is pivoted relative to the housing to open and close the tool. In certain tools, the trigger is also actuated to project the fastener from the tool. The fastener is typically fed into the tool from a magazine. The magazine is usually disposed within the housing. The magazine typically includes a number of individual fasteners arranged in a stacked relationship, and may be either detachable or fixed within the tool. Typically, the magazine can be loaded with fasteners from the front of the tool. Generally, the tools are actuated by the trigger in a manner so that the fastener is automatically projected when the trigger is pulled. The new act allows private insurance companies to sell insurance that could include coverage for abortions. The bill said that private insurers could offer plans that include coverage for abortions for procedures related to rape or incest or where the health of the mother is at risk. Plans that do not cover such procedures would be subject to additional regulations. The bill stated that any federal, state or local law that barred the use of federal funds to pay for abortion services in any of these circumstances would not apply. In cases of rape or incest, the bill said that insurers could not charge women higher premiums or increase the cost of premiums because they do not provide coverage for abortions. The legislation proposed that insurance companies that offer plans that do not cover abortions would have to notify any individual in that group who wanted to buy such a plan of the cost of the coverage and make a comparison to an individual who already has such a plan. It also said insurers could not refuse to issue policies to individuals because of the policies they already have or because they want to purchase a separate insurance plan to include coverage for abortion. People who wanted to purchase an abortion-only plan would have to pay full cost for the procedure, and any cost-sharing or deductible would have to be paid by the woman, not the insurer. The bill stated that the federal funds that pay for abortions for low-income women with incomes up to 250 percent of the poverty level would be prohibited from paying for abortions for women who are not poor. The House bill introduced by Rep. Mike Pence, R-Ind., would eliminate a requirement for women to wait 72 hours after having a procedure before being able to obtain an abortion. The current law requires women to wait that amount of time to make a decision on having an abortion. Other provisions in the House bill include a provision requiring that any abortion be performed in an ambulatory surgical center. The bill would also require women who are having an abortion to undergo a sonogram. It would prohibit the use of federal funds for abortions. The current law prohibits the use of federal funds for abortions except in cases of rape, incest or to save the life of the woman. The Senate bill introduced by Sen.
